- ◆ Driving Range included, Club Storage (optional charge).

CLASS ‘A’ MEMBER (Yearly dues: \$1,825.00)

- ◆ Have 14 days in advance to make reservation for tee times during the week and 7 days for weekends and holidays.
- ◆ Have no restrictions from play at any time, except when previous bookings have been made, (ie: Outside tournaments, members tournaments, and members social events) these events will be posted in advance.
- ◆ Service package included with dues.

SENIOR CLASS ‘A’ MEMBER (Yearly dues: \$1,340.00) (age of 60 years or more @ April 1st)

- ◆ Have 14 days in advance to make reservation for tee times during the week and 7 days for weekends and holidays.
- ◆ Have no restrictions from play at any time, except when previous bookings have been made, (ie: Outside tournaments, members tournaments, and members social events) these events will be posted in advance.
- ◆ Service package included with dues.

PLAYING SPOUSE (Yearly dues: \$1,205.00)

- ◆ Have 14 days in advance to make reservation for tee times during the week and 7 days for weekends and holidays.
- ◆ Have no restrictions from play at any time, except when previous bookings have been made, (ie: Outside tournaments, members tournaments, and members social events) these events will be posted in advance.
- ◆ Service package included with dues.

FAMILY MEMBERSHIP (Yearly dues: \$3,275.00)

- ◆ Eligible to participate in Ladies Night League play.
- ◆ Service package included with dues.

CORPORATE MEMBERSHIP

- ◆ Corporate 1 Membership allows the corporation to have up to five (5) employees belonging to one membership.

INTERMEDIATE CLASS ‘A’ MEMBERSHIP (Yearly dues: \$1,275.00) (ages 31 – 35 @ April 1st)

- ◆ 22% portion of yearly dues is applied to “Initiation Fee” to be used once member reaches 31 years of age
- ◆ Have 14 days in advance to make reservation for tee times during the week and 7 days for weekends and holidays.

RULES & REGULATIONS

GENERAL MATTERS

- ◆ Our club is 'Soft Spike' only (mandatory).
- ◆ **All members and guests are required to register in the golf shop (15 minutes) before play begins.**
- ◆ All players must start at the #1 tee unless otherwise instructed by the ProShop.
- ◆ Play in more than foursomes is prohibited unless approved by the ProShop.
- ◆ The ProShop shall have full responsibility and authority for starting players and regulating play. Their decisions are final, including removal of players not following the rules and regulations.
- ◆ Each player must have a set of clubs.

THE DRESS CODE

MEN:

- ◆ Shirts with collars and sleeves at all times on the course.
- ◆ No muscle shirts, mid-chest or fish net tops.
- ◆ Tennis, Bermuda, and walking shorts allowed.
- ◆ No sweat-pants, cut-off's, running shorts, gym shorts, or bathing suits allowed.
- ◆ Proper footwear is required at all times.

WOMEN:

- ◆ Shirts should have collar or sleeves.
- ◆ Tennis, Bermuda, and walking shorts are allowed.
- ◆ No running shorts, cut-off's, or bathing suits allowed.
- ◆ Proper footwear is required at all times.

OUTSIDE TOURNAMENTS

(groups of more than 16 players)

- ◆ There will be no outside tournaments on weekends and holidays before 2:00 p.m..
- ◆ Tournaments during the week will tee off between 10:00 am and 2:00 p.m..
- ◆ The club reserves the right to host on average one 'shotgun' tournament per week. These tournaments normally tee-off at 12:00 noon and should be finished by approximately 5:00 p.m.

BOOKING PROCEDURES

- ◆ See Membership Category Information page.
- ◆ Members have 14 days to book tee times during the week and 7 days for the weekends.
- ◆ We will allow our 'non-member' guests to book 7 days in advance with the use of a credit card.

DAILY GREEN FEES

(excluding Tournament Green Fees)

- ◆ 18 Hole Green Fee... \$43.00 – restricted on weekends & holidays until after 12:00 p.m. unless accompanied with a member.
- ◆ 18 Hole Guest Rate (playing with member)...

Weekends & Holidays (after 11 am)...	\$40.00
Weekdays (anytime)...	\$40.00
Weekends & Holidays (before 11 am)...	\$43.00
Senior Rates (where applicable)	\$36.00

- ◆ No golf clubs and bags are to be stored in the lockers or locker room area.
- ◆ The Club reserves the right to remove any additional locks or clubs from locker room.
